### **Crown Castle NG Atlantic LLC Request for a Name Change**

Dear Mr. Collins:

Crown Castle NG Atlantic LLC (formerly known as Crown Castle NG Atlantic Inc.) (the "Company") hereby notifies the Commission that the Company's current name is "Crown Castle NG Atlantic LLC" as a result of its conversion from a Delaware corporation to a Delaware limited liability company. The conversion of the Company to a limited liability company was merely a change in its corporate form accomplished through the filing of Certificate of Conversion in Delaware and did not entail any merger or other transactions that extinguish the existence of the Company. The Company requests that the Commission updates its records, including the Company's Authorization,<sup>1</sup> to reflect its current name, "Crown Castle NG Atlantic LLC" and to the extent necessary approve these changes.

The Company's conversion documents and authority to transact business in Maryland are provided as Attachment 1 hereto. The Company will separately file a replacement tariff(s) reflecting these changes upon request.

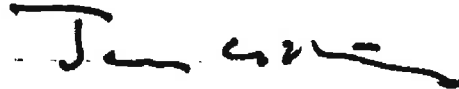

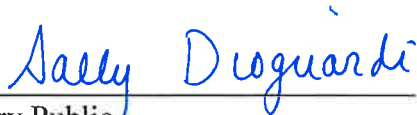
