ORDER APPROVING NAME CHANGE

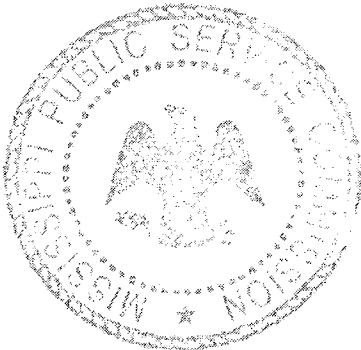

THE COMMISSION FINDS that this matter reflects a name change only and does not represent a change in ownership or management and will not affect the manner in which business will be conducted in the State of Mississippi.

THE COMMISSION FURTHER FINDS that this is a routine administrative procedure and usual notice and the necessity for a hearing should be and the same is hereby waived.

IT IS THEREFORE ORDERED, that the request of NextG Networks of Illinois, Inc. d/b/a NextG Networks Central to change its name to Crown Castle NG Central LLC is hereby granted.

ORDER

On July 26, 2010, NextG Networks of Illinois, Inc. d/b/a NextG Networks Central ("NextG") filed with the Mississippi Public Service Commission an Application seeking a Certificate of Public Convenience and Necessity to provide facilities-based and resold local exchange and interexchange telecommunications services throughout the State of Mississippi. The Commission, being fully apprised in the premises and having considered the documents, prefiled testimony, and record before it, as authorized by law, and upon recommendation of the Public Utilities Staff, finds as follows:

1. On July 26, 2010, NextG filed with the Commission its Application.
2. The Commission has jurisdiction to enter this Order, and entry hereof is in the public interest.
3. Due and proper notice of the Application was given to all interested persons as required by law and by the Commission's Public Utilities Rules of Practice and Procedure.
4. There were no intervenors or protestants of record in this matter before the Commission.

5. NextG is a Delaware corporation and is qualified to do business in Mississippi. NextG maintains its headquarters at 890 Tasman Drive, Milpitas, California.

6. NextG will offer point-to-point transport service over fiber optic lines. NextG markets its service primarily to providers of retail wireless service and acts as a "carrier's carrier" for such providers. NextG does not have a contractual relationship with any retail end users of the wireless service. NextG's service provides transport services to the wireless carriers who then serve retail consumers. Although NextG provides carriage services for wireless carriers and NextG's networks may incorporate or connect wireless elements, NextG does not itself provide any wireless service.

7. NextG will provide its services throughout the State of Mississippi. NextG is currently authorized to provide its point-to-point carrier's carrier transport service in Kansas, Illinois, Missouri and Texas, and NextG affiliates operate in additional states.

8. NextG is qualified and financially capable of providing its service. NextG and its management team have extensive experience in the technical, managerial, and financial aspects of the telecommunications industry. NextG has submitted, under confidential seal, financial statements that demonstrate that it has sufficient strength to provide and maintain the services.

9. Granting NextG authority to provide the services described herein is in the public interest. Permitting NextG to provide the services will expand options available to the Mississippi market and increase competition in Mississippi. Approval will lead directly to substantial, additional private investment in Mississippi's telecommunications infrastructure and promote choice in the marketplace by expanding the availability of innovative, high quality, reliable and competitively priced telecommunications services.

IT IS, THEREFORE, ORDERED by the Mississippi Public Service Commission as follows:

1. NextG Networks of Illinois, Inc. d/b/a NextG Networks Central ("NextG") is hereby granted authority to transact the business of a facilities-based and resold local exchange and interexchange telecommunications services throughout the State of Mississippi as described herein.

2. NextG's tariff, filed as Exhibit "E" to the Application, is hereby approved.

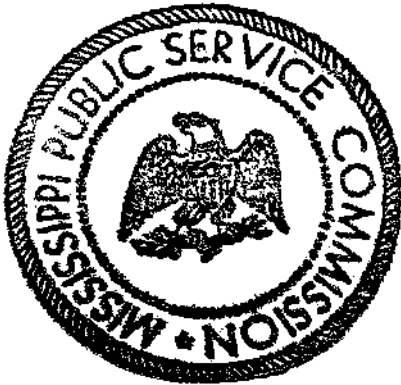
3. Under the authority granted herein, the services provided by NextG are not services provided to the end user retail customer. Therefore, the slamming provisions of Amended Order Adopting Rule 47.1, in Docket No. 98-AD-90 do not apply to NextG.

4. This Order shall be deemed issued on the day it is served upon the parties herein by the Executive Secretary of this Commission who shall note the service date in the file of this docket.
